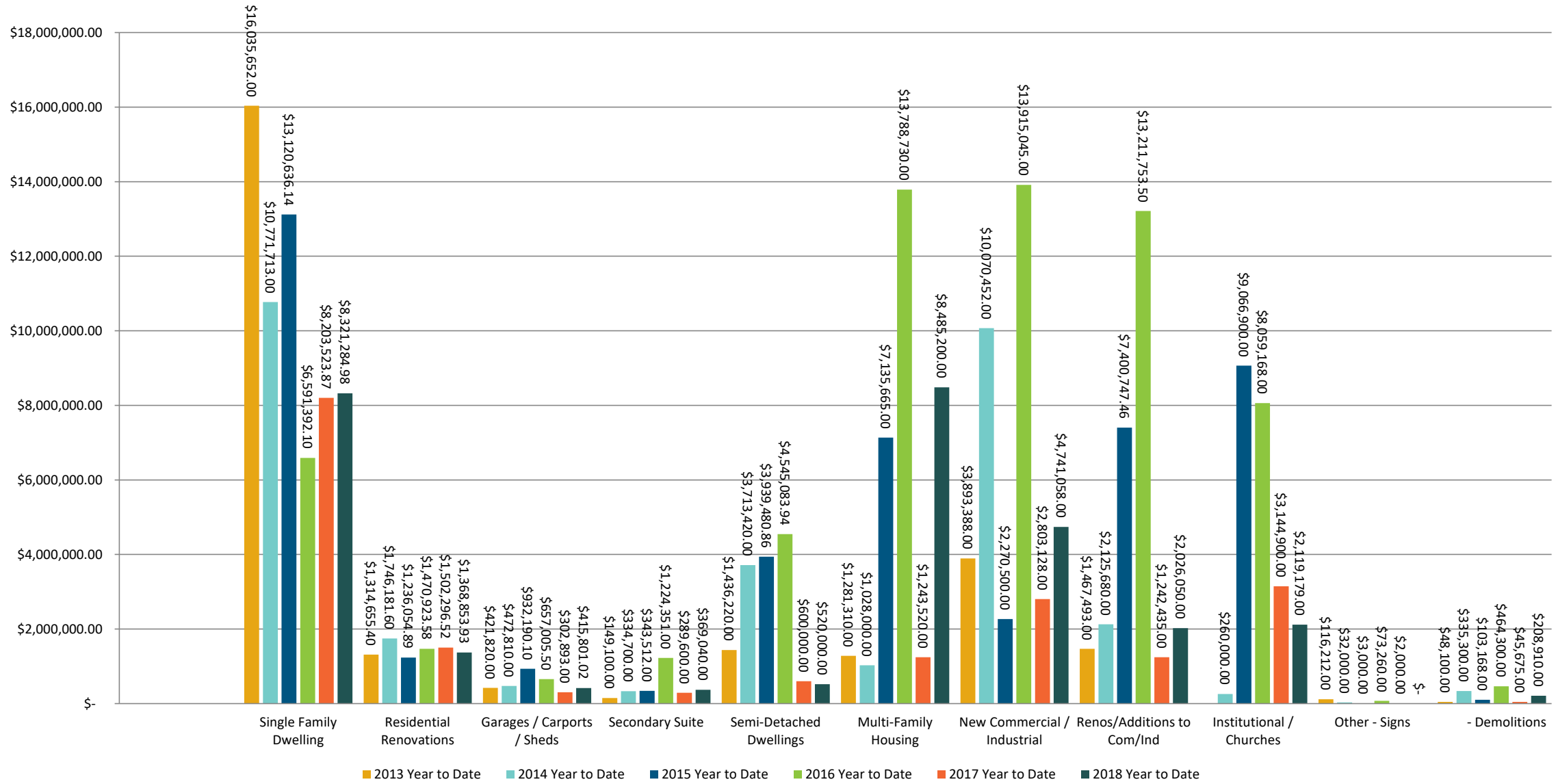

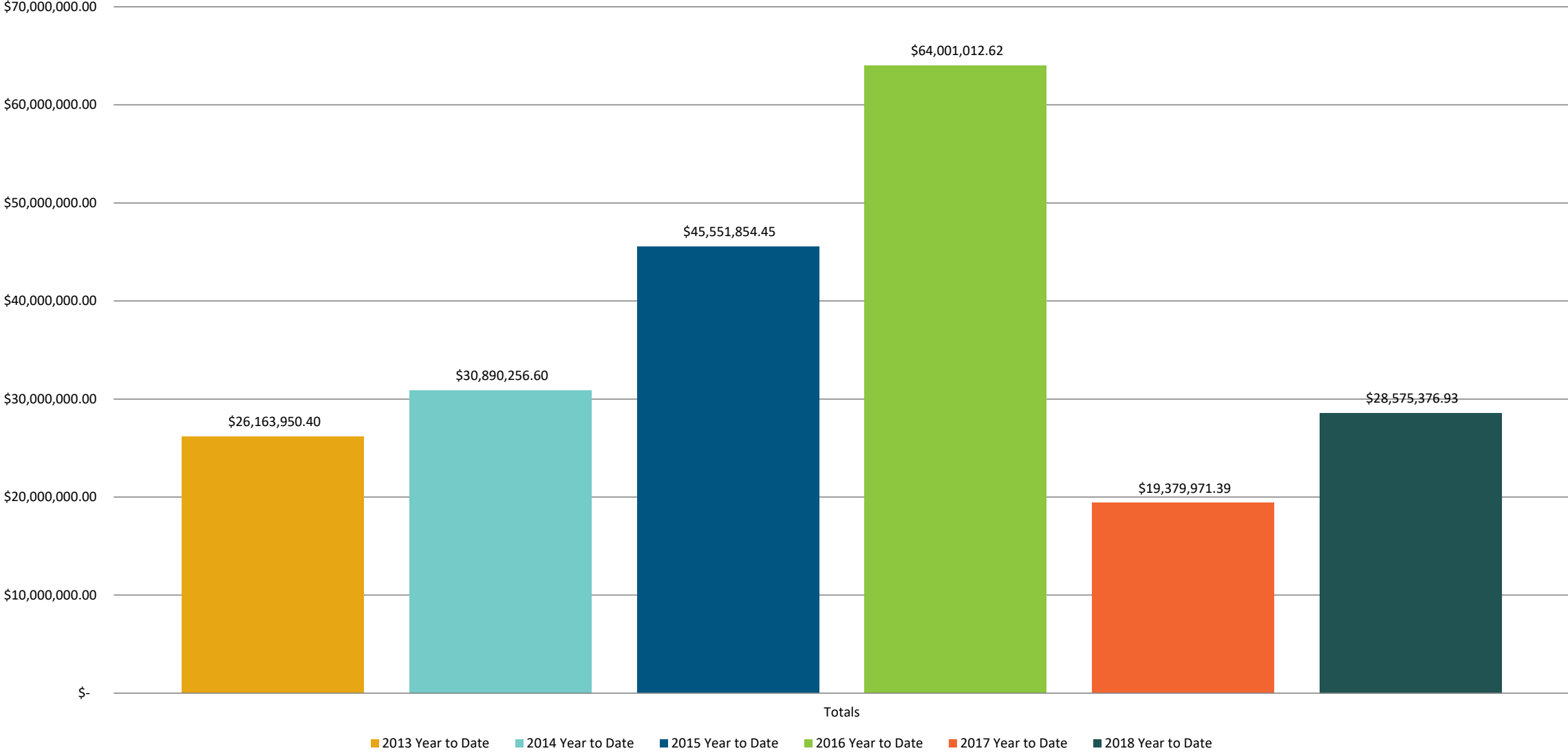

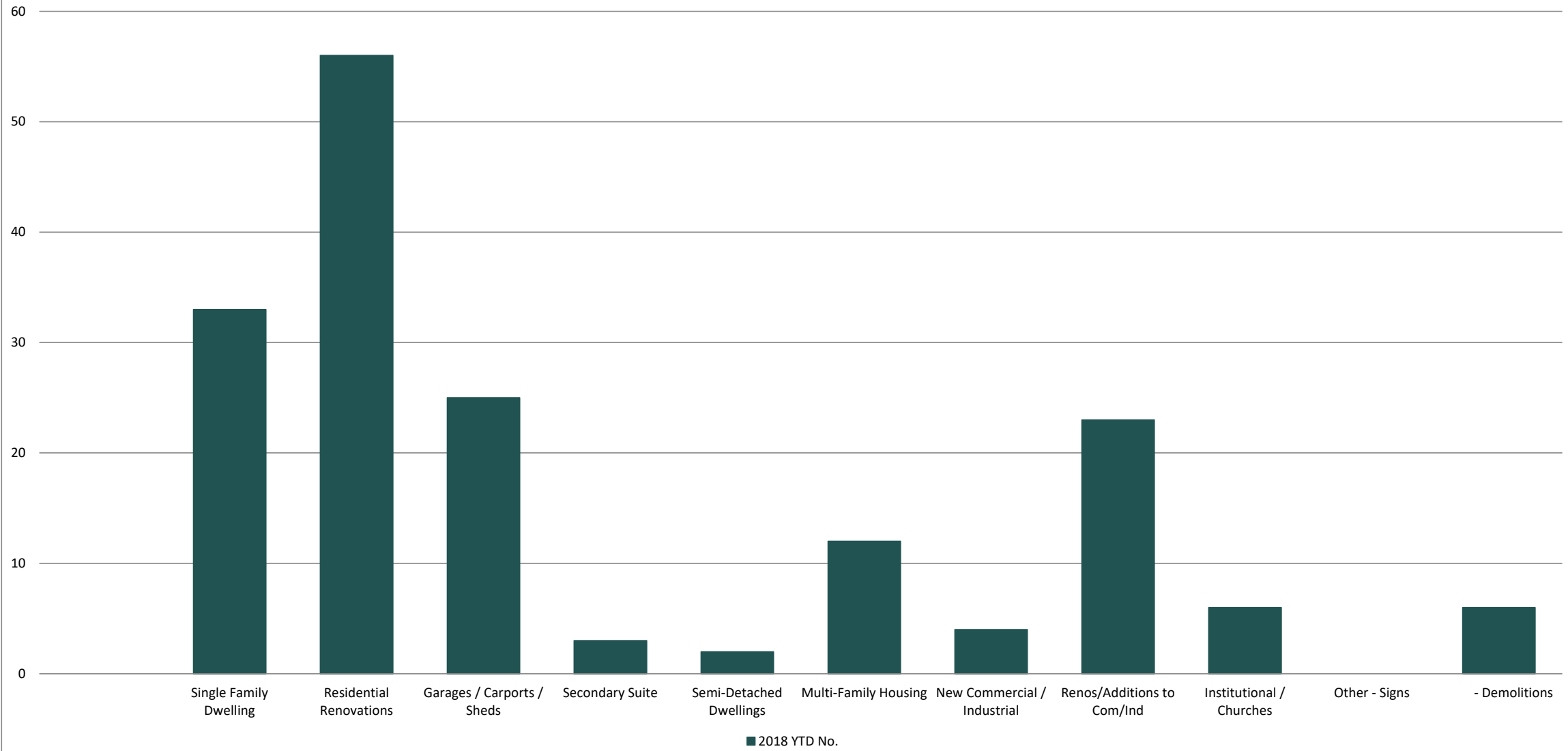
### YTD Permit Values - November



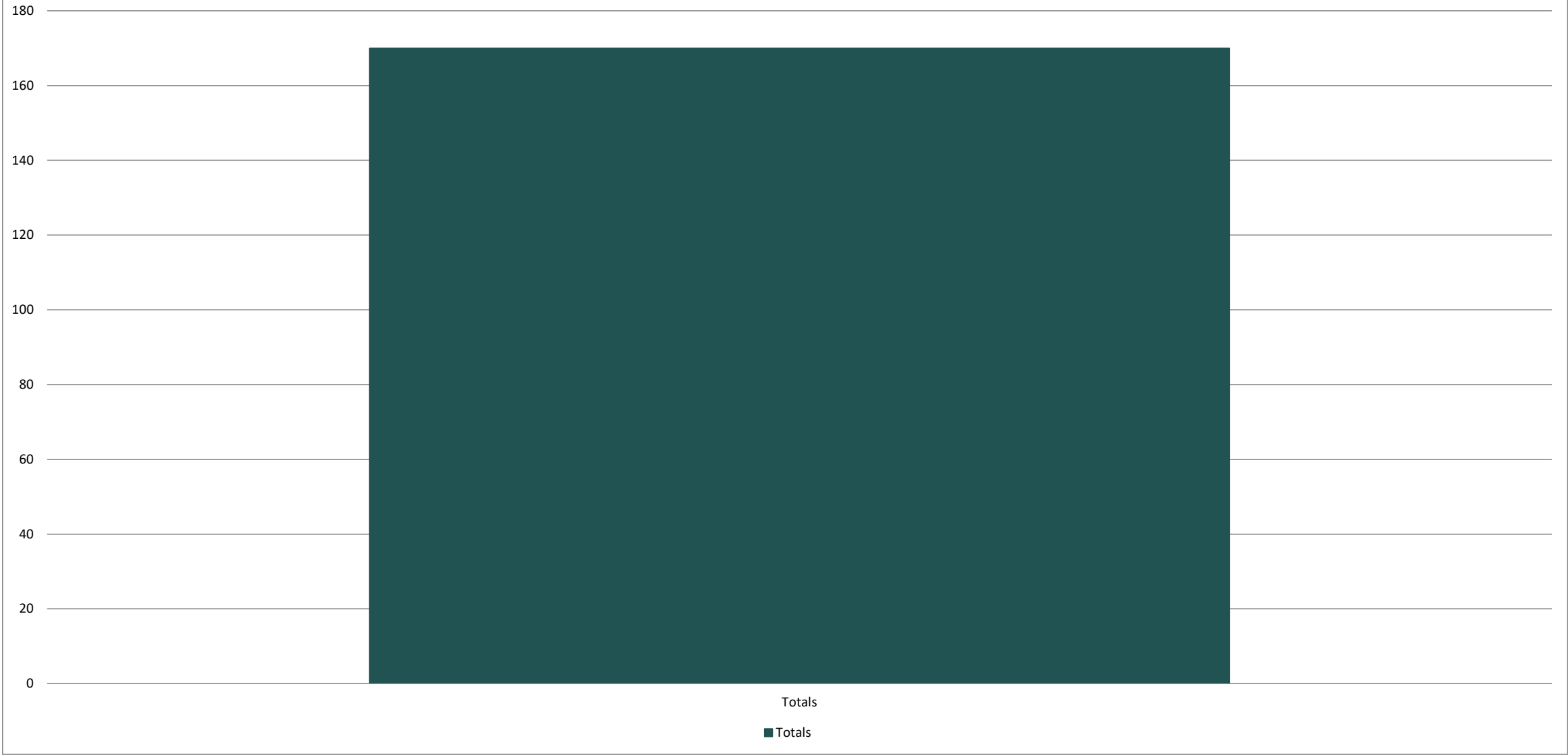
### YTD Total Permit Values - November



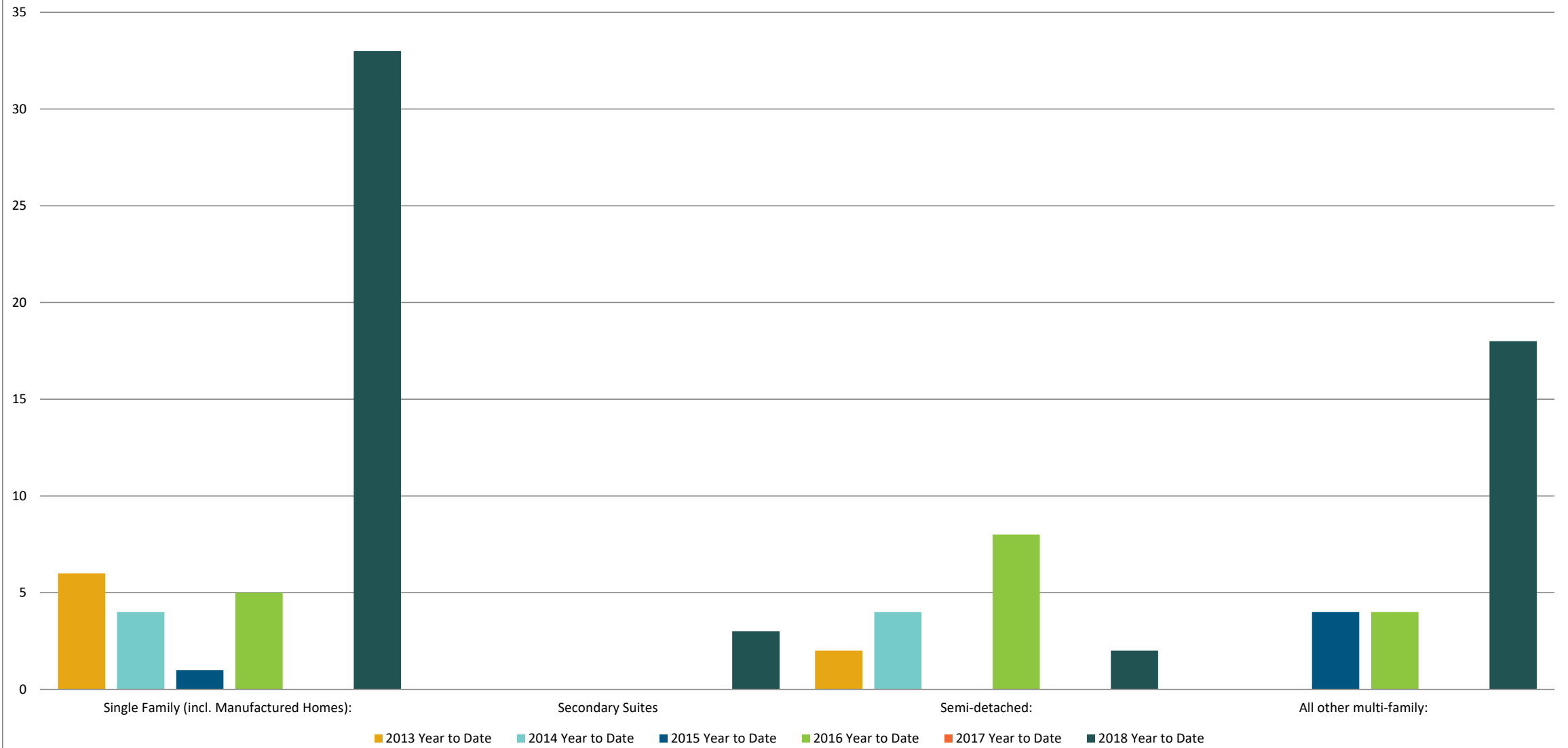
### YTD Permit Numbers - November
