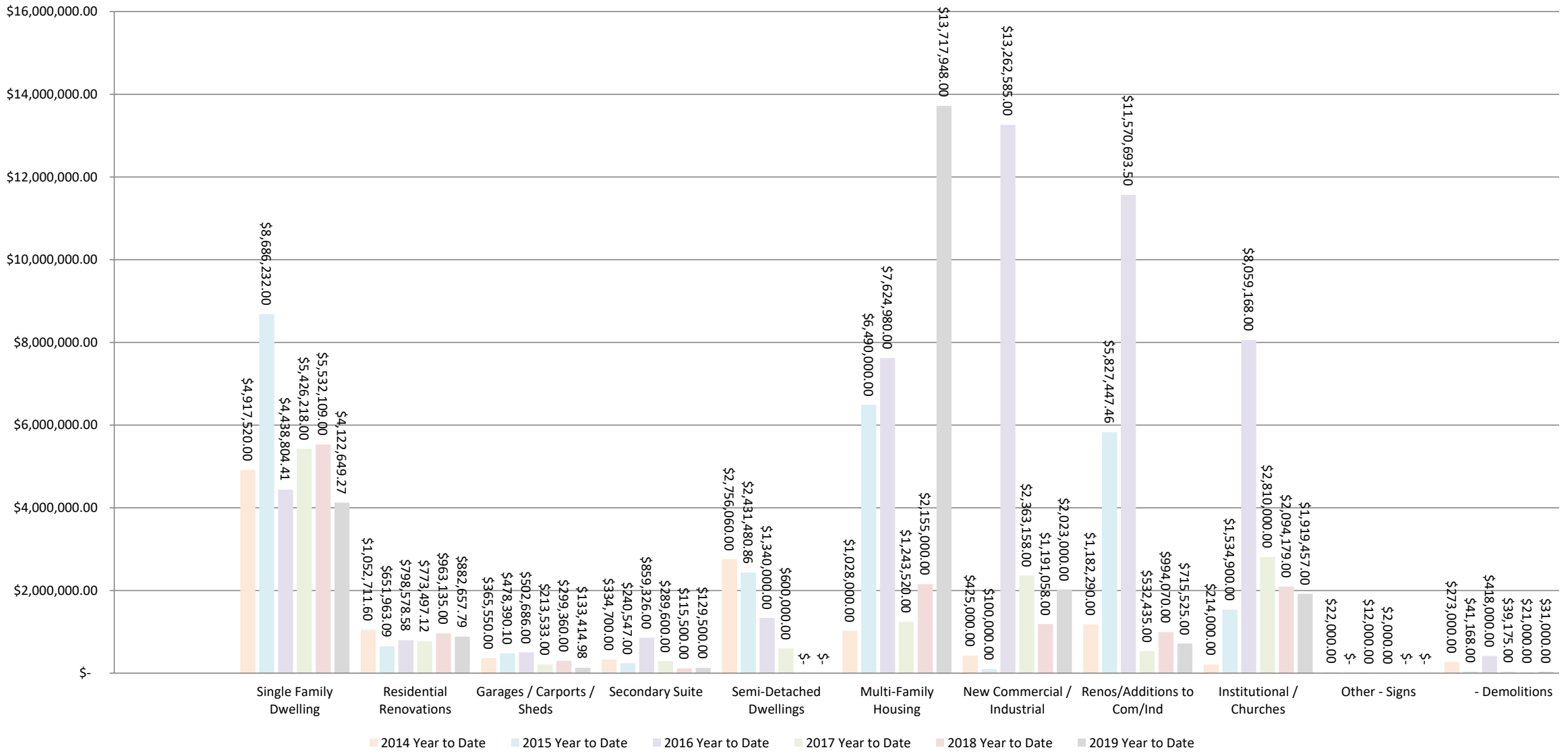

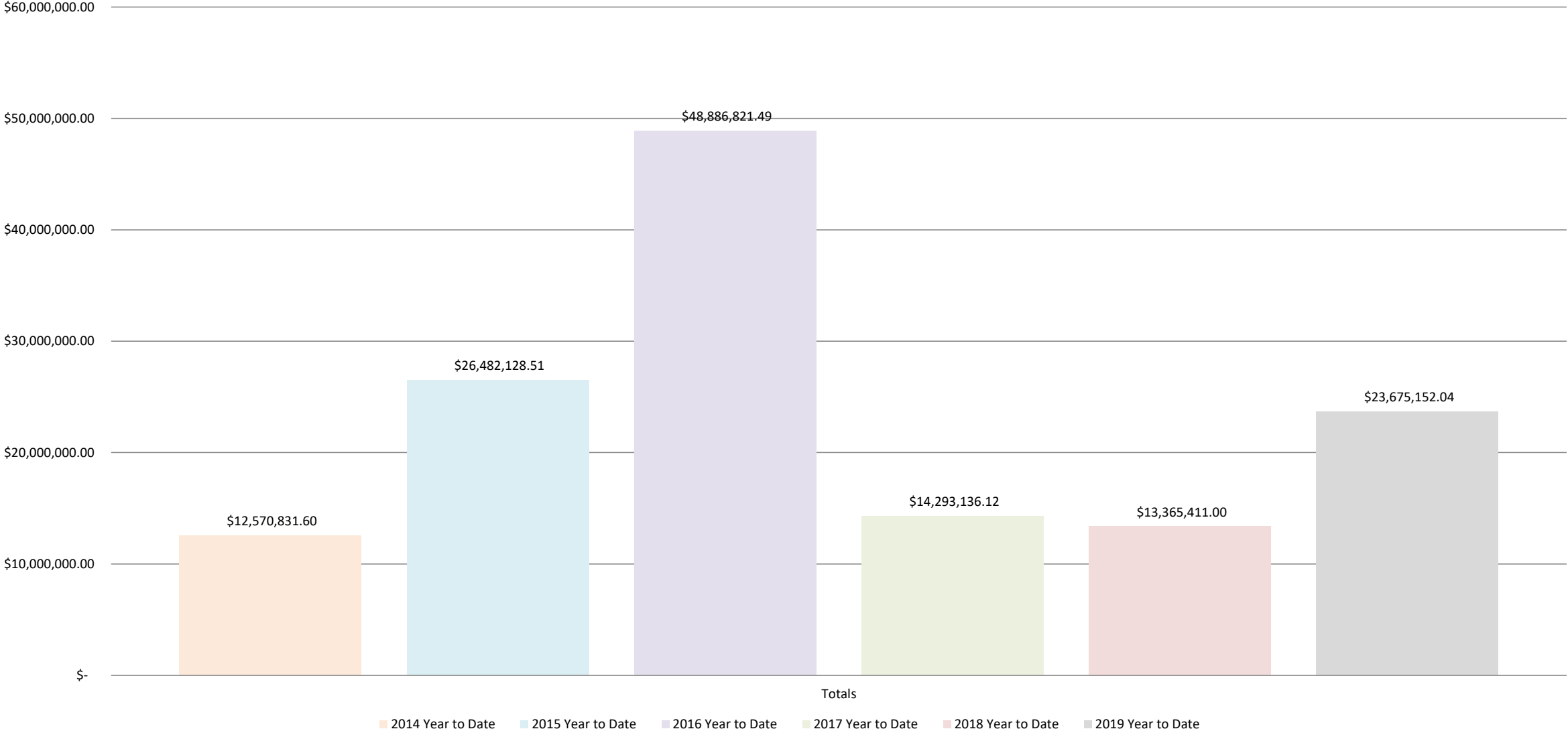

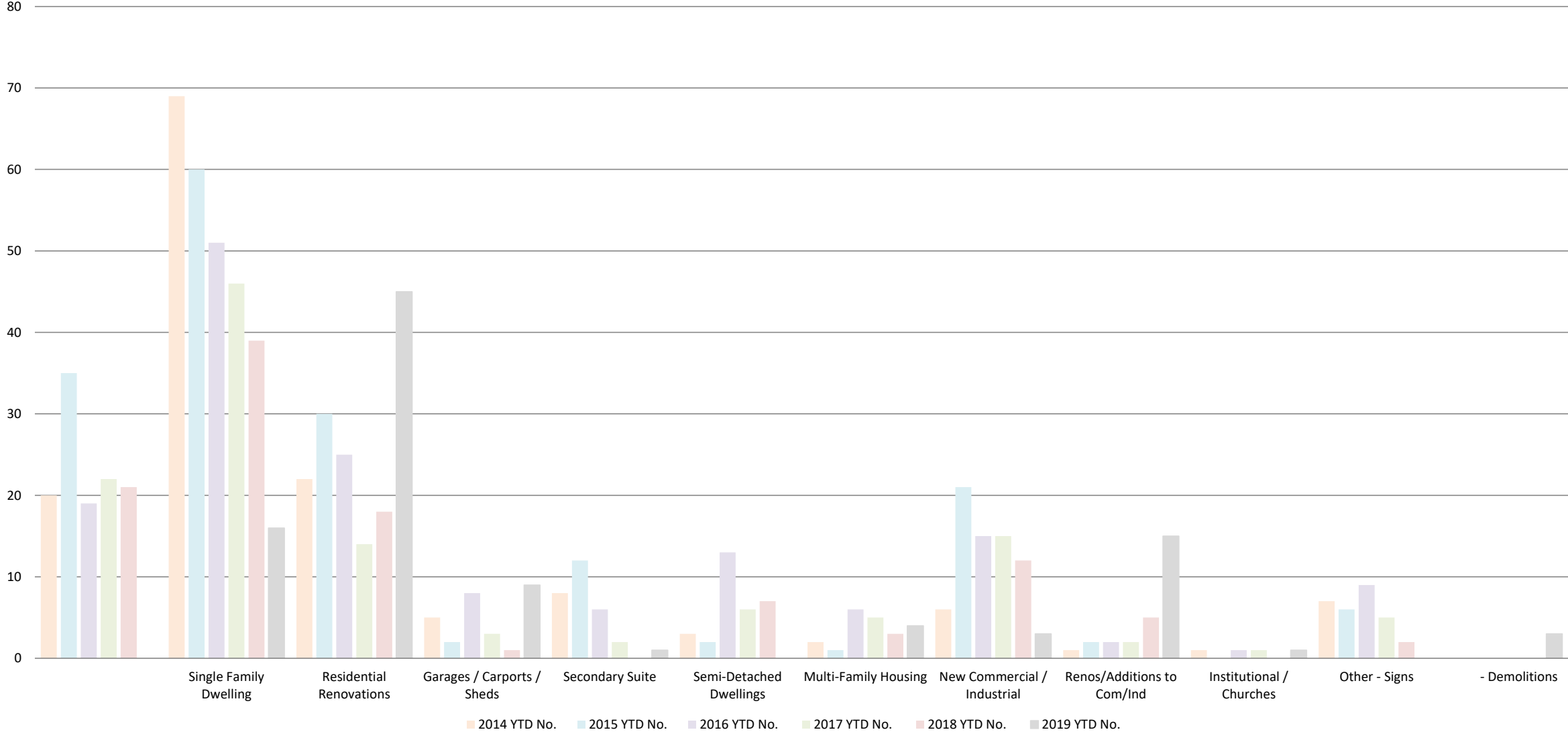
YTD Permit Values - July



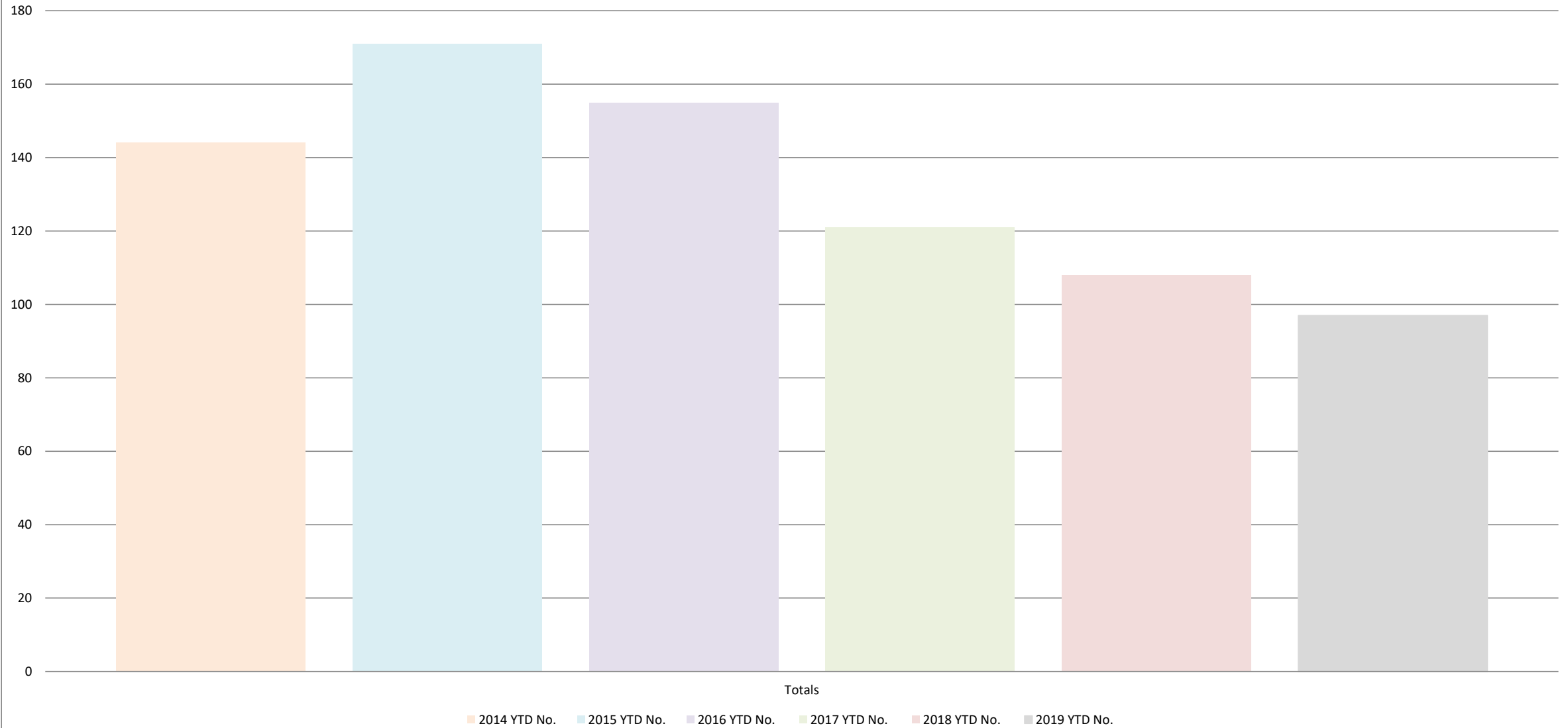
YTD Total Permit Values - July



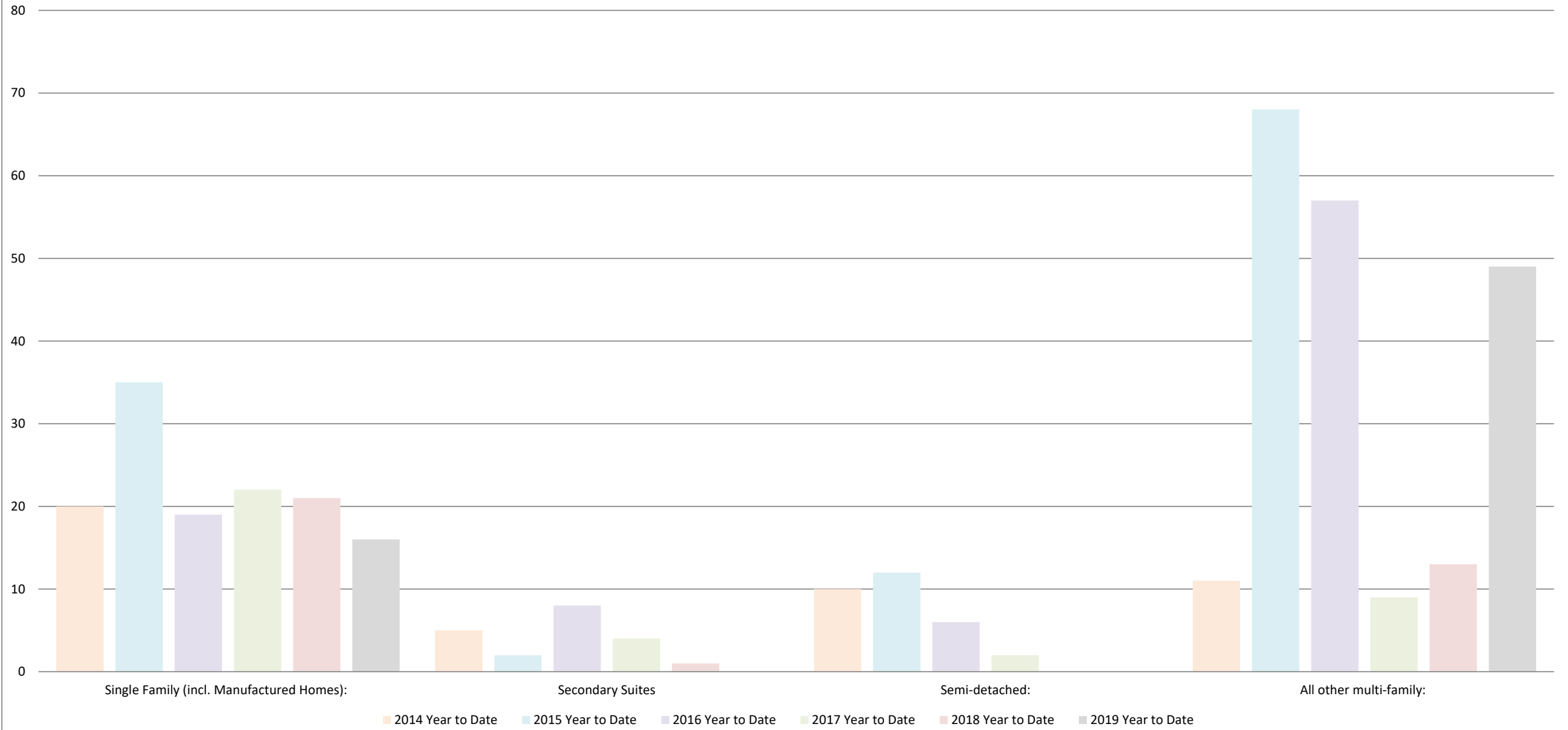
YTD Permit Numbers - July
