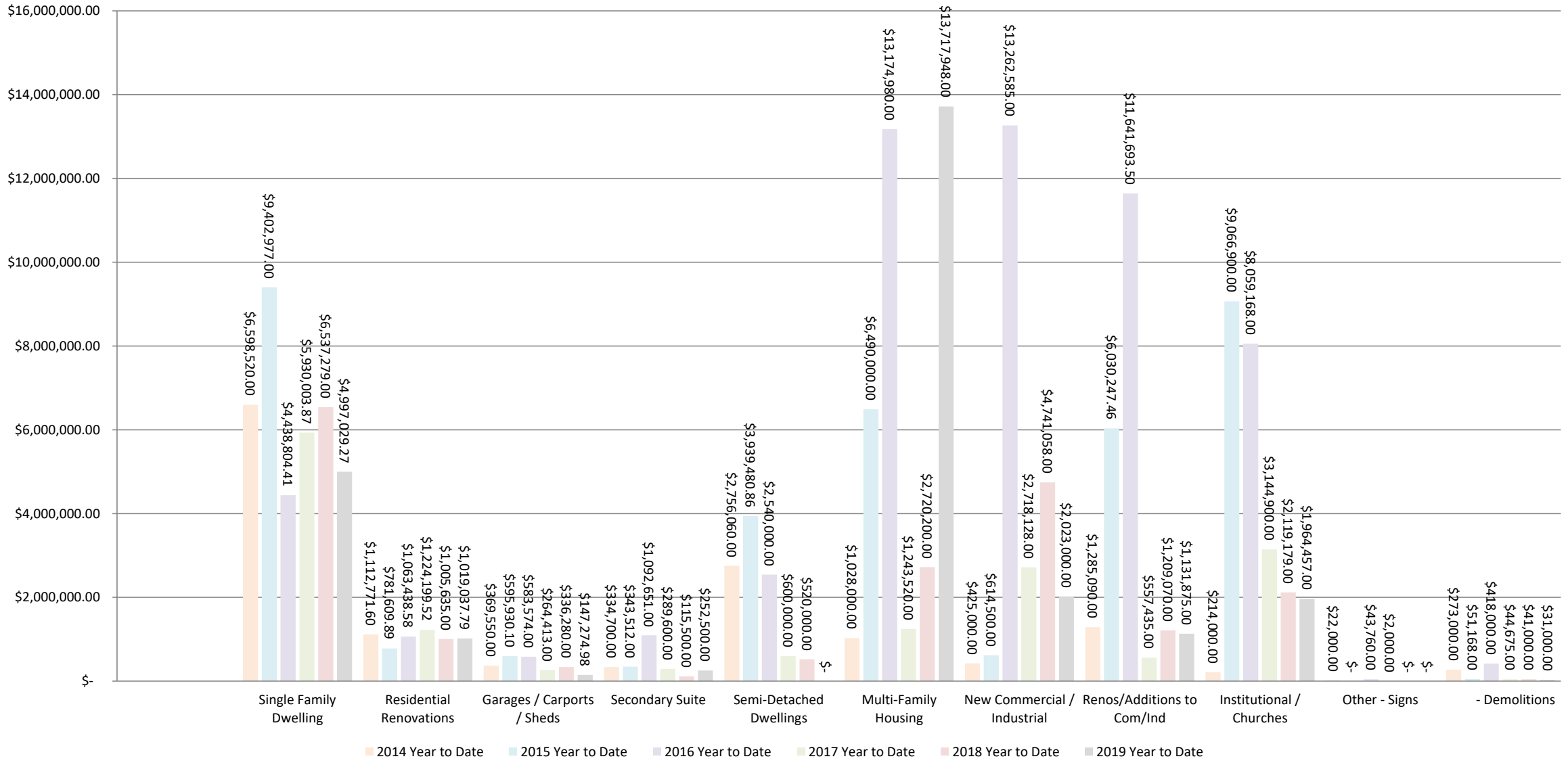

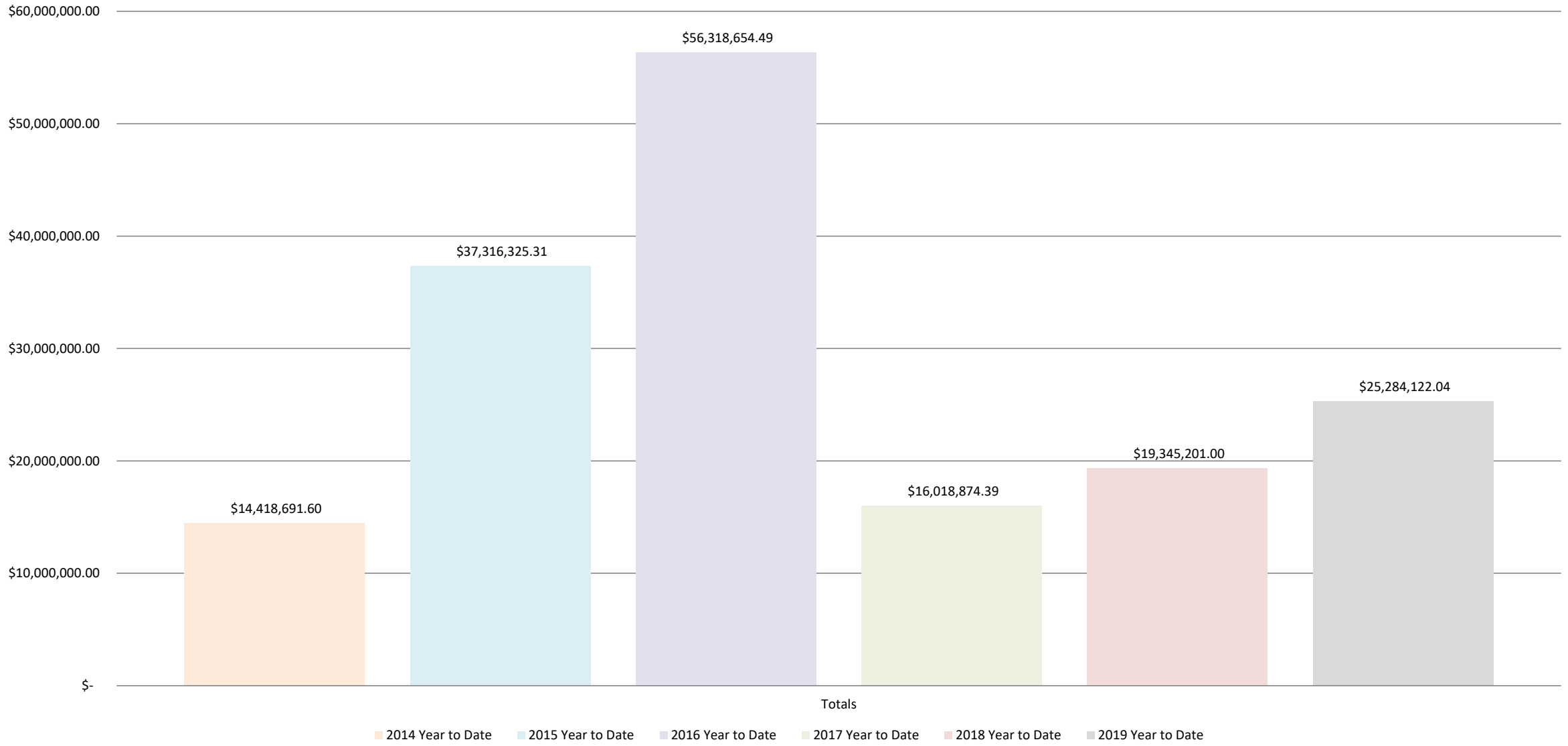

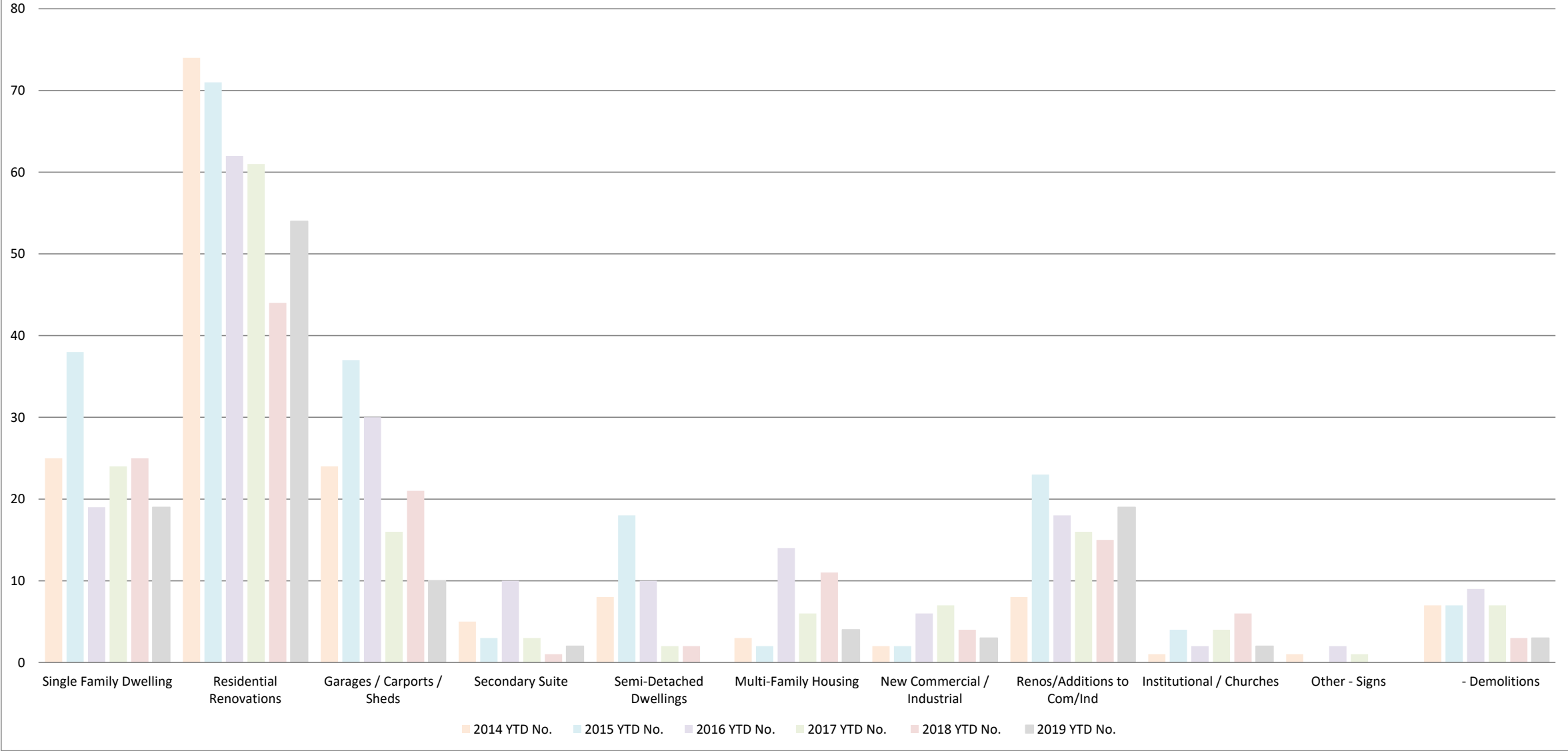
### YTD Permit Values - August



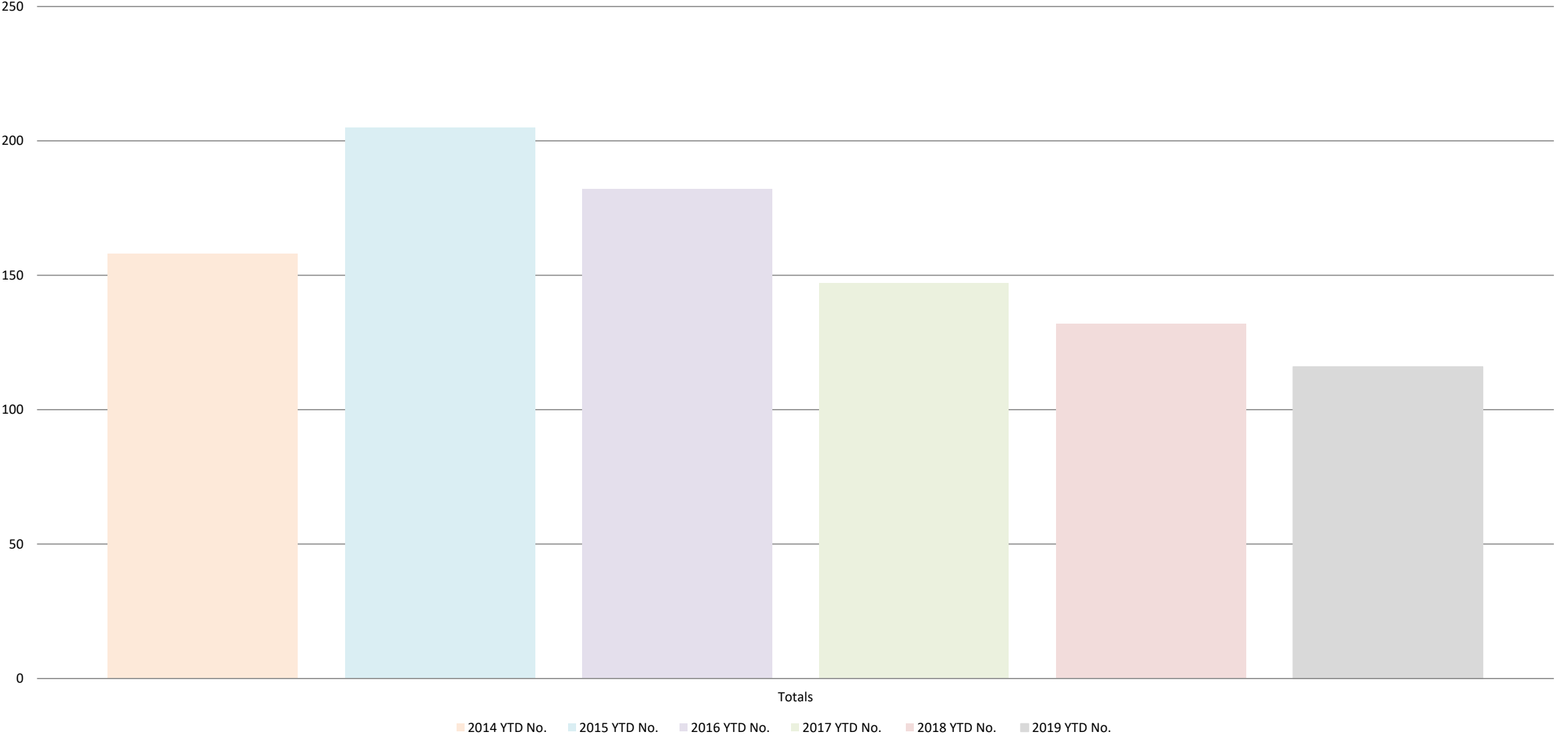
### YTD Total Permit Values - August



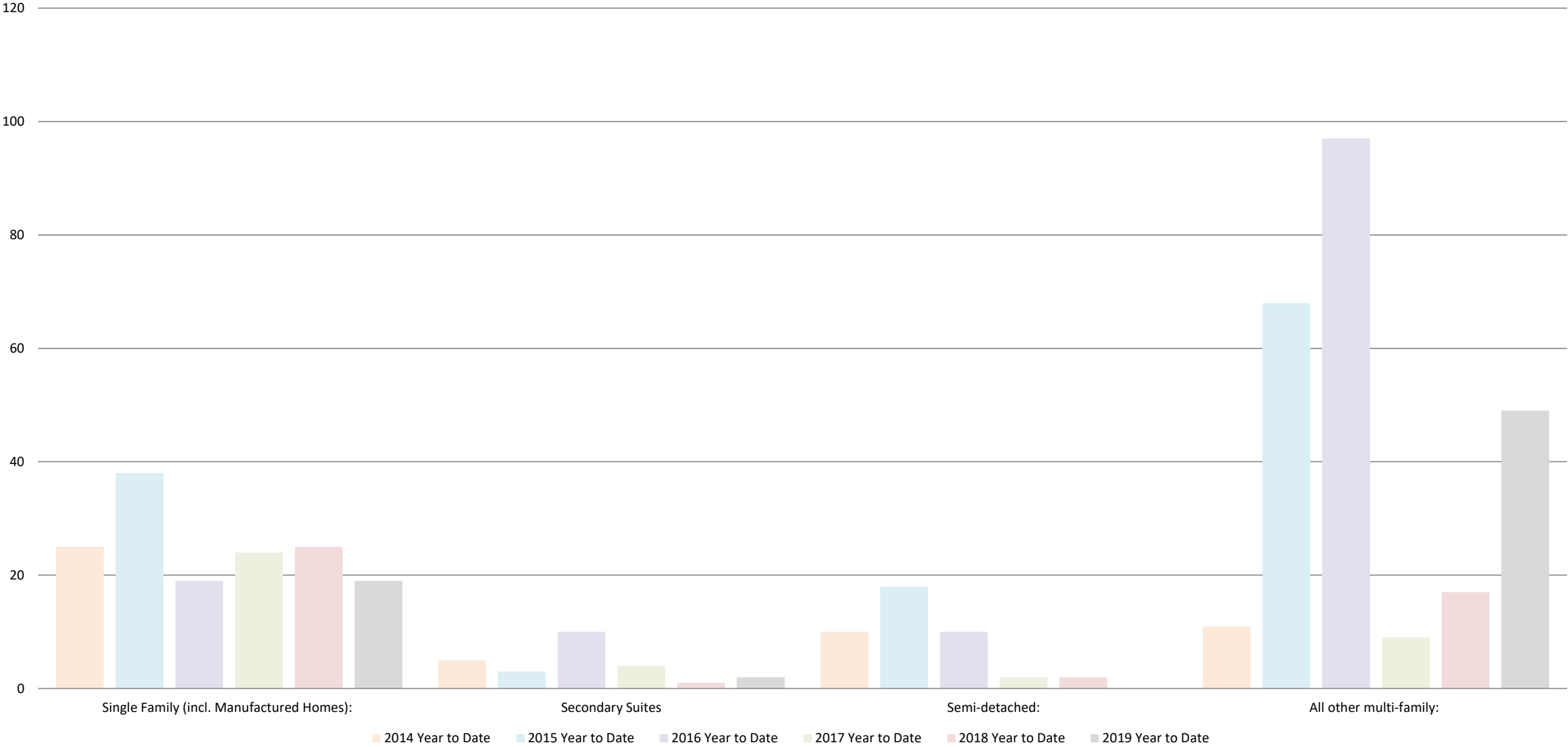
### YTD Permit Numbers - August
