

## **TOWN OF LACOMBE BYLAW 85**

A Bylaw of the Town of Lacombe, in the Province of Alberta to adjust the terms of office for the citizen members of the various boards and commissions of the Town of Lacombe.

WHEREAS the citizen members of Municipal Police Commission, the Lacombe and District Family & Community Support Services Board, the Lacombe and District Family and Community Services - Lacombe Committee, the Economic Development Board, the Lacombe Library Board, the Kinsmen Ball Park Committee and the Parkland Place Meeting Room Committee are appointed at the Town of Lacombe Organizational Meeting; and

WHEREAS the said Organizational Meeting in years of municipal elections is held within 2 weeks of the election which at times can present difficulty in arranging the various appointments to Boards and Commissions; and

WHEREAS it is desirous to have the terms of office for the citizen members of the various boards and commissions to take effect January 1st;

NOW THEREFORE BE IT RESOLVED THAT:

1. Bylaw 78, a bylaw to provide for a Municipal Police Commission be amended by:
  - a. deleting the words "two year term" from Section 3.(3)(a) and by deleting the dates October 31st, 1988 and October 31st, 1987 and substituting the dates December 31, 1988 and December 31, 1987 respectively
  - b. deleting the words "the Organizational Meeting" from Section 3(3) and substituting the words "a meeting".
2. The appointments of the Public Members made to the Municipal Police Commission under resolution 86-459 be extended through December 31 of the appropriate year.
3. The citizen appointments made to the Family and Community Support Services Board under resolution 86-462 be extended through December 31 of the appropriate year.
4. The citizen appointments made to the Lacombe and District Family and Community Support Services Board - Lacombe Committee under resolution 86-463 and resolution 86-490 be extended through December 31 of the appropriate year.
5. Bylaw 74, a bylaw to establish the Municipal Planning Commission of the Town of Lacombe, be amended by substituting the words 'the annual organizational meeting' with the words 'a meeting of Council' in Section 3.3.
6. The citizen appointments made to the Municipal Planning Commission under resolution 86-465 be extended through December 31.
7. Bylaw 75, a bylaw to establish the Development Appeal Board of the Town of Lacombe, be amended by substituting the words 'the annual organizational meeting' with the words 'a regular meeting of Council' in Section 3.3.
8. The citizen appointments made to the Development Appeal Board under resolution 86-466 be extended through December 31.
9. Bylaw 64, a bylaw to establish an Economic Development Board for the Town of Lacombe, be amended by substituting the words 'the Organizational Meeting' with the words 'a regular meeting' in Section 6.
10. The citizen appointments made to the Economic Development Board under resolution 86-467 and resolution 86-490 be extended through December 31.
11. The citizen appointments made to the Lacombe Library Board under resolution 86-470 be extended through December 31.
12. The citizen appointments made to the Kinsmen Ball Park Committee under resolution 86-471 be extended through December 31.

13. The citizen appointments made to the Parkland Place Meeting Room Committee under resolution 86-472 be extended through December 31.
