### Planning and Development Services

#### Bylaw 400.06 – (Rezone R1 to GS &C2)

City of Lacombe Bylaw 400.06, an amending Bylaw of the City of Lacombe to rezone lands described as part of SW 32-40-26 W4 from Residential Detached District (R1) to Greenspace District (GS), and Neighbourhood Commercial District (C2) and rezone Lot 22, Block 3, Plan 912 0069 from Residential Detached (R1) to Greenspace District (GS).

The Executive Assistant advised Council the purpose of the public hearing is to hear any public submissions on the rezoning. Per Section 606 of the MGA (Requirements for Advertising), Public Hearing notice was advertised in the Lacombe Express Thursday September 28 and Thursday October 5, 2017. It was confirmed that no submissions were received.

### **Development Officer or Designate**

Matthew Goudy, Director of Operations and Planning Services, presented Bylaw 400.06 to rezone lands described as part of SW 32-40-26 W4 from Residential Detached District (R1) to Greenspace District (GS), and Commercial District (C2) and Lot 22, Block 3, Plan 912 0069 from Residential Detached (R1) to Greenspace District (GS).

#### Those in Favour of the Bylaw

Darrel Humphreys, Lacombe resident, came forward in support of Bylaw 400.06 with questions regarding the current Greenspace. Mr. Humphreys outlined his concerns on the maintenance of the trees in the Greenspace, asking that, should the City take ownership, who they could approach for care and maintenance. Mr. Humphreys also requested further clarification on the zoning for Commercial District (C2).

## Any Person Deemed to be Affected Who Wishes to be Heard

Darrell Salewski, Lacombe resident came forward deemed to be affected by the proposed Bylaw amendments, and noted that Lot 1 from the map, appears to be a stranded lot with no access from a public road and if the City does not proceed with the land swap, he asked what is the life of that property and/or how can it develop if there is no access, also asking what would be the process to gain access to the lot with a public road?
